- Issuance of Provisional NOC in favour of -

The undersigned is directed to refer to the letter no.844-SC/AI dt.27.12.99 of the Director of School Education (AIS), West Bengal on the above subject and to state that the State Government in the School Education Department hereby gives provisional 'No objection Certificate' to the Secondary Wing of Hem Sheela Model School, Jawaharlal, Nehru Avenue, Durgapur, Distt.- Burdwan for the purpose of preparing its candidates to appear in the final examination of the Central Board of Secondary Education under the following terms and conditions :-

1. The State Govt. will not bear any financial liability of the school.
2. The school will not enhance tuition/other fees without prior express approval of the State Government;
3. The School pay its teaching and non-teaching staff emoluments at a rate which will not be less than those of their counterparts with equivalent educational qualifications in State-aided educational institutions;
4. The school will provide for the contributory provident fund for the employees as prescribed under the relevant Provident Fund Act/Rules of the Government of India;
5. 10% (ten percent) of the new admission in the school in each academic year will be allowed on the recommendation of the School Education Department and 50% of such students will have to be allowed to pursue studies in the school free of any cost;
6. Violation of any of the conditions laid down in sub-para (2), (3), (4) and (5) shall entail withdrawal of the 'No objection' of the State Government with effect from the beginning of the academic year next to that in which violation is committed.




